

COP9 and MOP2

In view of the COVID-19 global pandemic and its impact on the conduct of global conferences and travel, it has not been feasible to organize a face-to-face sessions in The Hague, Netherlands, as initially planned for the Ninth Session of the Conference of the Parties (COP9) to the WHO Framework Convention on Tobacco Control (WHO FCTC) and the Second Session of the Meeting of the Parties (MOP2) to the Protocol to Eliminate Illicit Trade in Tobacco Products. Therefore, both meetings will take place virtually, with COP9 running from 8 to 13 November 2021 and MOP2 from 15 to 18 November 2021.

COP9 and MOP2 campaign

Since few months, we have kicked-off an online campaign to gain the momentum for the two upcoming COP9 and MOP2. Furthermore, we have been inviting Nongovernmental organizations (NGOs) and International intergovernmental organizations (IGOs) to apply as observers of the Conference of the Parties and to the Meeting of the Parties.

Visuals and themes for the campaign

The theme for the **COP9** is *tobacco control during a global health emergency*. And the theme of the **MOP2** is *implementation of the Protocol to Eliminate Illicit Trade in Tobacco Products*.

The logos and the visual identity





The inspiration of the logos of each conference were alludes to the "human" aspect of the work – using pixel-inspired representations of people to refer to the digital nature of the meetings and setting them against a circular background to evoke the globe/the environment.

The interconnectedness of the human figures embodies the need to strengthen collaboration even more so during this challenging time. COP9 and MOP2 logos must be always accompanied by the logo of its respective treaty, like the example below.


