We have affiliated organizations in Buenos Aires, Argentina (FIC Argentina); La Paz, Bolivia (FIC Bolivia); and Mexico City, Mexico (FIC Mexico). FIC means Fundaci?n Interamericana del Coraz?n, the Spanish name for our organization. We also have a branch in Kingston, Jamaica, for the English-Speaking Caribbean.

* As tobacco has been our top priority for many years, our meeting almost always discuss tobacco control in our region and individual countries.

We have organized 5 Latin American and Caribbean Tobacco or Health Conferences for our region, the latest in Montevideo, Uruguay in June 2017. Our organization is frequently a participant in workshops by PAHO and Campaign for Tobacco Free kids. We have grants that involve tobacco control and we have meetings related to those projects.

* Our regional office was not able to participate at the last COP due to lack of funding. But our affiliated organizations FIC Mexico and FIC Argentina were engaged. Also our economist consultant, who is also a member of the Board of the FCA, attended and supported civil society positions.

IAHF is also in official relations with PAHO and we attend the annual Directing Council meetings where we always have interventions in the name of civil society on tobacco issues.

* Please list any other meetings or conferences with a focus on tobacco control attended by your organization:

* Many members of our organization attended the World Conference Tobacco or Health in Cape Town recently. Our own regional conference the 5th Latin American and Caribbean Tobacco or Health Conference in Montevideo, Uruguay, June 2017 convened about 400 participants from 25 countries. Key partners were CTFK, PAHO, IDRC, ACS, AHA, JHSPH, SRNT, among others. 5 plenaries, 21 concurrent sessions, 7 workshops, approximately 140 speakers and chairs, posters, awards, exhibitors, media impact. * IAHF moderates the CLACCTA list-serv which includes tobacco advocates. Art. 5. 3 on interference of the industry is a main topic of discussion. Art 5.3 is frequently noted when we or partners organize letter campaigns.

IAHF participated in a meeting that took place in Panama on this subject.

FIC Argentina, one of our affiliated organizations, organized a major region wide campaign Alto a las Tabacaleras or Stop the Tobacco Industry. Regional monitoring and responding to tobacco industry strategies. Monitoring of tobacco industry strategies at the point of sale.

* If yes, please provide details: * IAHF with FIC Argentina co-organized an NIH Fogarty funded research program "From Production to Retailing, policy-oriented research on tobacco economy in Argentina." This project was the basis for the successful effort to raise tobacco taxes in 2017. FIC Argentina, together with the Argentina Ministry of Health and Ministry of Finance received a Bloomberg Award for this accomplishment at the Cape Town conference March 2018.

* If yes, please provide details: * FIC Argentina, the O'Neill Institute and ASH obtained an audience with the Inter-American Commission on Human Rights to encourage treating tobacco as an affront to human rights. The key message was related to children's exposure to tobacco smoke and industry disregard for basic human right to health. The proposed comprehensive tobacco control legislation that FIC Bolivia has been shepherding for now almost 2 years, includes Art 8 clause, as well as

They regularly organize media campaigns, legislative forums, coalition building training, among other means of educating and communicating about tobacco control.

* Art 13 is part of the proposed comprehensive legislation FIC Bolivia is fighting for in the Bolivian Assembly. IAHF and CTFK provide weekly consultation.

* If yes, please provide details: * Supported implementation of FCTC Article 14 in Bolivia, Mexico and Costa Rica working with Ministries of Health to develop National Strategies on Cessation. National Situation Analyses conducted in Bolivia and Mexico. Full plan approved in Uruguay. Organized capacity building program for healthcare professionals for our region in brief advice and train the trainer to increase number of instructors that could provide training. Used models developed by WHO.

Project is still underway.
