Cameroon adopted a law in July 2020 authorizing the President to ratify the Protocol on the Illicit Trade in Tobacco Products, followed by a decree on July 27, 2020. However, the Protocol still remained to be ratified by Cameroon. In 2023, with the financial assistance of Vital Strategies, ATCA provided technical assistance to its country partner in Cameroon to develop and disseminate the Tobacco Industry Interference Index report. It also produced communication materials used in a series of advocacy activities aimed at political decision-makers with a view to finalizing the ratification of the Protocol. We understand that the ratification documents will soon be dispatched to the United Nations. Follow-up is in progress.

Article 23: As a Pan-African network of civil society organizations with more than 120 organizational members across 39 African countries, ATCA has the biggest civil society network for the monitoring of the tobacco industry in Africa. It has established Tobacco Industry Monitoring and Response (TIMR) Teams in several countries to serve as watchdog to the tobacco industry, denouncing and exposing its numerous activities contrary to existing legislations and policies. ATCA also partners with the Global Centre for Good Governance to prepare the Tobacco Industry Monitoring Index, the last edition of which saw the participation of 18 African countries. These projects require that ATCA organizes regular trainings for its TIMR teams as well as for government officials and the media. The illicit trade in tobacco products, in which the tobacco industry is well known to be deeply engaged, has a prominent place in ATCA's training programmes. Our country partners, and especially the media, are empowered to keep the illicit trade in tobacco products high on their advocacy agenda with decision-makers.
