- * A core competency of the ACS is its work on tobacco taxation and illicit trade, and the economics of tobacco control more generally. We work actively to counsel governments and other organizations on this topic. We generate a great deal of research directly about this topic area. We are now actively engaged in the Meeting of Parties process of the Protocol to Eliminate Illicit Trade in Tobacco Products, including through consultation with the Secretariat directly and in our role as observer. We are supporting a number of Parties directly on issues related to illicit trade. Here is a sampling of our recent work:

Expert/Ministerial Meetings Attendance

As a consultant to the FCTC Secretariat, ACS staff attended the Meeting of Parties for the Protocol to Eliminate Illicit Trade in Tobacco Products, and the Working Group on Tracking and Tracing and the Working Group for Assistance. Similarly, ACS attended regional meetings as experts on the Protocol held in late 2019 in Jamaica and Latvia. We are supporting the FCTC2030 project actively in Zambia, Nepal and Sri Lanka on Article 6.

ACS-Funded Projects with In-Country Partners

MERCOSUR (Argentina) -measuring illicit trade in eight cities in Argentina. Preliminary results available as of early 2020.

Bangladesh - (co-funded with CRUK) - costs of tobacco survey-based study (designed to support tobacco tax increases). The report was launched in 2019.

Brazil - (co-funded with Johns Hopkins IGTC) - measuring illicit trade to counter industry arguments against tobacco taxation in 5 cities. Report will be launched in May 2020.

Colombia - (second wave co-funded with CRUK) - two studies measuring illicit trade to counter industry arguments against tobacco taxation (two waves, one before a tobacco tax increase and one after).

Mexico - (co-funded with Johns Hopkins IGTC) - working with the sanitary and addiction authorities, , a study measuring illicit trade in 8 cities to counter industry arguments against tobacco taxation. Full report was launched in 2019. A new follow-up study is already underway.

Papua-New Guinea - working with consultants to the Ministry of Health to develop a plan for fees on tobacco products to mimic taxation.

Peru - (co-funded with CRUK) - per the request of the finance ministry, a study of elasticities of demand for tobacco products with an emphasis on youth in order to support tobacco taxation policies. A second study nearing completion as of February 2020 measures illicit trade in tobacco products in three large cities.

- * Tobacco growing and the environment are also core areas of focus of the ACS team. We are working with governments in at least 7 countries right now on this issue. We have been actively working with the FCTC2030 project in Zambia on tobacco farming as it is a major obstacle to the new comprehensive legislation. We are also working with the UNDP-led programme (with FCTC2030 support) to develop a social impact bond to help tobacco farmers find viable economic alternatives.

ACS-Funded Research Projects

We currently have a large US National Institutes of Health-funded research project to evaluate the livelihoods of current and former tobacco farmers in Kenya and Zambia (as well as two non-Parties and major tobacco leaf producers, Indonesia and Malawi). We augment this programme with our funds (total of ~300,000 USD per year). We recently began collaborating with McGill University to expand the project to Mozambique and Zimbabwe (roughly 200,000 CAD per year). ACS is sole-funding a project to measure livelihoods in Chile. In all countries, a major focus is helping to find farmers viable alternatives to growing tobacco and to debunking tobacco industry myths about farmers' prosperity.
