We regularly hold webinars and townhalls for our members at both the global and regional levels and tobacco control and FCTC is almost always the main topic covered during the meetings. We cover a range of topics such as the COP as a whole or more detailed topics such as reporting on 3.a., shadow reporting, industry interference, budget advocacy, sustainable development and tobacco control etc. In the lead up to the COP and the MOP, we hold meetings and events for each region and globally and discuss the agenda in more detail and also discuss advocacy strategies and how we will collaborate during the deliberations. During the COP and MOP we also hold daily meetings and briefings with our membership to discuss strategies. We also provide tailored information and advocacy materials on tobacco control to our members on a regular basis.

## E1. Please provide any other relevant information

In 2020 the FCA began developing a compressive report entitled: Options for sustainable funding mechanisms for FCTC implementation which was launched in 2021 and includes four key sections and creates an evidence-based narrative to address the funding shortfall challenge.

In 2021, the WHO FCTC Secretariat officially launched a guide for WHO FCTC Parties on including SDG Target 3.a and 3.4 in Voluntary National Reviews (VNRs). The Alliance was the lead author of the report and was instrumental in the guides creation. We are happy to continue working alongside the Convention Secretariat on promoting this important initiative. Throughout 2021 and 2022, we continued creating and circulating new resources to stakeholders and partners in the tobacco control community in support of this initiative.

Over the course of 2022, the Alliance undertook several initiatives to better align tobacco control with global health and development. We achieved this through Alliance led projects and by participating in several leading initiatives to raise the profile of tobacco control in this space

At COP9 and MOP2 decisions were made to establish an Investment Fund for each respective area. In 2022 the organization supported the establishment of the Investments Funds by:

on Liaising with the FCTC Secretariat and developing key messages around the importance of adopting the proposal for the Investment Funds

or Coordinating a meeting for all NGO Observers to the COP to discuss which Observers would sit on the Oversight Committee for the Investment Funds

o Assisting applicants in completing their applications to sit on the Oversight Committee

o? Circulating of a letter of support from the NGO Observers to endorse the candidacy of the applicants

Through its participation in COP9 and other WHO FCTC related meetings, FCA has provided coordination for civil society participation in, and support of, the negotiations and implementation of the WHO FCTC. FCA continues to provide evidence-based background and policy briefing materials, produced in all six official WHO languages, and conduct research and provide technical expertise. Through its global reach, FCA has been able to enlist the expertise necessary to develop recommendations for sound policies to assist Parties to the WHO FCTC during their deliberations. FCA, through its member representatives at FCTC COP9, contributed actively to the development of the FCTC by organizing the following:

o? the development and distribution of FCA policy papers on key issues of the decisions;

o?providing a daily bulletin newsletter covering topical issues and policy positions

In addition, FCA used Alliance resources to support participants from low- and middle-income countries who would not have otherwise been able to attend COP9.

Other organizational notes:

As per our ongoing discussions with Sabina Timco lacazzi and Dominique Nguyen, the Framework Convention Alliance on Tobacco Control (FCA) has taken important steps to dissolve the FCA in Switzerland and incorporate in to Canada. In consultation with our Members, we have also taken steps to rebrand the organization and continue operations as the Global Alliance for Tobacco Control (GATC).

Given that nothing of substance in our applications for the status of observer to the Conference of the Parties (COP) and Meeting of the Parties (MOP) has changed, we kindly request that the FCTC Secretariat maintain our observer status for both the COP and MOP under our new name, the Global Alliance for Tobacco Control (GATC).

A letter to this effect is being prepared and will be sent to the FCTC Secretariat to formalize the request and changes.
