- * We were co-principal investigators with FIC Argentina in an ACS funded project to evaluate illicit trade in MERCOSUR countries with the purpose of advancing taxation in these countries.

Presently advancing a program to increase awareness among students of economics at the undergraduate and graduate levels, regarding health economics and the important connection between tobacco and economic development. Additionally, with expert health economists in our region, we are working to develop a factsheet and policy brief to use with Ministers of Finance

* If yes, please provide details: * We worked for 3 years on proposed comprehensive tobacco control legislation in Bolivia and it was just last week promulgated by the President of the Senate, a rare situation given the provisionary status of the current Bolivian President. We are also working with the Dominican Republic to advance SFE legislation. Compliance with existing legislation, given many new tobacco products, is a challenge but we are supporting efforts in many countries.

* Article 11 (Packaging and labelling of tobacco products)? * Yes
* If yes, please provide details: * The Bolivian legislation contains warning label clause. We also had a part in supporting President Tabaré Vázquez in advancing plain packaging of tobacco in Uruguay. Additionally, we have regular conference calls with Ecuador advocates that have a plain package proposal stuck in congress at the moment.

* If yes, please provide details: * IAHF participates in actions for World No Tobacco day and celebrations such as the current 15th anniversary of the FCTC entering into force. There are others as opportunities arise.

* If yes, please provide details: * This is one of the weakest strategies in our region. We disseminate information about Tobacco Industry actions to reach young people in below-the-line marketing. We support the Yul. Francisco WhatsApp group to help disseminate ways in which this Article is violated.

* We have worked to develop national tobacco dependency strategies with Ministries of Health in Mexico (won Bloomberg Awards in So Africa), Bolivia, Argentina and Costa Rica. The approach follows Art 14 Guidelines. We would like to continue this very important effort but have not found funding.

* If yes, please provide details: * With funding from American Cancer Society, we worked in partnership with FIC Argentina to evaluate illicit trade in Mercosur countries. In particular we were responsible for disseminating results to the region

* From the Healthy Latin America Coalition, we have advanced a Human Rights perspective to seek accountability of the highest level authorities. One example from a few years ago is the report to CEDAW regarding women and girls being affected by Argentina not complying with tobacco policies. More recently we reported on various industries (tobacco, alcohol, unhealthy foods, and drink) to the

Interamerican Commission on Human Rights and our points were incorporated into a report on industry and HHRR. In particular, it was mentioned that these industries were violating the right of children to well-being and the rights of all to health.
