The flagship meetings of the World Heart Federation are the World Congress of Cardiology and the World Heart Summit.

B6. Does your organization regularly convene meetings or conferences for its membership?

Tobacco remains a leading cause of cardiovascular morbidity and mortality. As such, sessions on tobacco control have been regularly featured in our Scientific and Summit programmes. Past sessions have covered electronic nicotine delivery systems as well as tobacco industry interference.

In addition, prominent leaders from the Tobacco Control community, such as Dr. Adriana Blanco Marquizo, Head of the Convention Secretariat, are also frequently invited to speak at our meetings.

The World Heart Federation regularly attends the biennial sessions of the Conference of the Parties to the WHO Framework Convention on Tobacco Control. The WHF delegation delivered a statement on agenda item 3: "Global Progress in the Implementation of the WHO Framework Convention on Tobacco Control" at the Ninth Session of the Conference of the Parties to the WHO FCTC in 2021. WHF also consistently attends the annual sessions of the WHO Executive Board, World Health Assembly, and WHO Regional Committees. The WHF delegation frequently delivers statements to promote tobacco control as well as the implementation of the WHO FCTC at the WHO Governing Bodies Meetings.

The World Heart Federation also collaborates with the WHO No Tobacco Unit (TFI) on various tobacco control projects, including World No Tobacco Day and the WHO Tobacco Cessation Consortium. Every year, WHF raises the profile of World No Tobacco Day through its communications channels (i.e., ensuring that its Members engage with the annual theme, etc.).

The World Heart Federation regularly drafts and/or endorses open letters to support its allies from the tobacco control community. For instance, WHF endorsed a joint statement issued by the Forum of International Respiratory Societies on the implications of Philip Morris International's acquisition of Vectura Group plc. WHF also endorsed a statement issued by the Southeast Asia Tobacco Control Alliance (SEATCA) to support the Ministry of Health of Malaysia on its Generational End Game policy proposal. In addition, WHF also supports tobacco control activities and initiatives conducted by its national members or global partners by providing resources and/or technical support, as appropriate.

The World Heart Federation is a core member of NCD Alliance and the Global Alliance for Tobacco Control (formerly known as the Framework Convention Alliance for Tobacco Control). WHF champions Cardiovascular Health for Everyone and advocates for the implementation of interventions and measures (e.g., taxation of unhealthy commodities, tobacco cessation, tobacco control, etc.) that reduce the burden of non-communicable diseases, including cardiovascular disease. In particular, we strongly advocate for the realization of the UN Sustainable Development Goals targets 3.4 and 3a.

In 2021, the World Heart Federation adopted and implemented a Conflict of Interest Policy to exclude all prospective speakers and delegates funded by the tobacco industry or its front groups, including the Philip Morris International-funded Foundation for a Smoke-Free World, from attending its event and congress. WHF will continue to promote Article 5.3 and aim to convince its Members to adopt and implement the aforementioned policy on tobacco industry representatives.

In 2022, the World Heart Federation provided a 10'000 USD grant to one of its Member for a project on "Tobacco Use and Youth". The selected project will aim to address tobacco advertising (i.e., billboards, etc.) near primary schools in Indonesia. WHF will be offering tobacco control grants in 2023 and 2024 as well.

In 2022, the World Heart Federation launched "World Heart Vision 2030" as a flagship initiative for global cardiovascular health which addresses strategic challenges and opportunities that the cardiovascular health community will face over the next decade. The initiative is intended to guide policy, advocacy, implementation, and communications efforts for the next decade in order to improve cardiovascular health, reduce health inequalities, and contribute to reducing the global burden of cardiovascular disease. In particular, tobacco control is acknowledged as a critical element to improving heart health. The report also recommends taxing unhealthy commodities (including tobacco), addressing tobacco use as a major risk factor for cardiovascular disease, preventing tobacco industry interference, and implementing the WHO Framework Convention on Tobacco Control.

Most WHF tobacco control activities and projects are steered and overseen by its Tobacco Expert Group.

In 2021, the World Heart Federation, in collaboration with the World Federation of Public Health Associations, co-hosted a webinar titled "Tobacco Control Talks: Tobacco Control Policies Matter" to highlight the impact of tobacco control policies and raise awareness of the links between tobacco and cardiovascular disease.

In 2021, the World Heart Federation organized a symposium on "The Role of Cardiologists and Other Cardiovascular Healthcare Professionals in Tobacco Control" at the 13th Asia Pacific Conference on Tobacco or Health. Panelists discussed the effects of tobacco use and second-hand smoke on the cardiovascular system, the findings of a study on tobacco and coronary heart disease, and the benefits of smoking cessation on cardiovascular health. The panel also reviewed the interplays between tobacco, COVID-19, and cardiovascular disease.

In 2021, the World Heart Federation launched its policy brief "E-Cigarettes: A New Threat to Cardiovascular Health" to summarize the latest evidence on, and raise awareness of, the effects of electronic nicotine delivery systems on cardiovascular health. The policy paper provided a series of recommendations to protect the general population, prevent initiation and uptake by non-smokers and youth, as well as address aggressive marketing strategies and misleading claims from the tobacco industry. Our policy brief on e-cigarettes was launched with an executive summary, an infographic, a Question & Answer page, a press release, and a social media campaign. The paper was referenced in multiple news outlets, including The Times.

In 2021, the World Heart Federation issued a letter to support the addition of all evidence-based tobacco cessation medications, including Bupropion and Varenicline, to the WHO Lists of Essential Medicines.

The World Heart Federation has been collaborating with the WHO Tobacco Cessation Consortium. WHF has attended the first Technical Working Group Meeting of the Consortium on 11 - 12 January 2023 in order to provide inputs on potential areas of collaboration. In particular, WHF has agreed to advocate for the integration of tobacco cessation interventions into NCDs and cardiovascular disease programmes. WHF has also agreed to support the activities of the Consortium through its Members at the national level. WHF will formally join the WHO Tobacco Cessation Consortium as soon as the application process opens.

The World Heart Federation developed an infographic on "Tobacco, the Environment, and the Heart" to raise awareness of the environmental impacts of tobacco for World No Tobacco Day 2022. In particular, the infographic highlights that tobacco harms our planet throughout its entire lifecycle - from cultivation, to manufacture, distribution, consumption, and disposal.

In 2022, the World Heart Federation launched its World Heart Observatory as a knowledge hub that curates, aggregates, and visualizes data on cardiovascular conditions, biological risk factors, social determinants of health, as well as health systems and policy responses. Data, stemming from the Global Burden of Disease Study 2019, on tobacco smoking, second-hand smoke, and cardiovascular disease can be consulted on the Observatory. WHF is also planning to add some original data from its Members and partners in due time (e.g., on tobacco control policies, etc.).

In 2020, the World Heart Federation collaborated with the World Health Organization and the University of Newcastle Australia to develop a "WHO Tobacco Knowledge Summaries" on "Tobacco and Coronary Heart Disease". The paper summarized the links between tobacco use and coronary heart disease, as well as outlined the benefits of tobacco cessation on heart health.

In 2021, the World Heart Federation, in collaboration with the American Heart Association, the American College of Cardiology, and the European Society of Cardiology, launched a joint opinion paper "The Tobacco Endgame—Eradicating a Worsening Epidemic" to call for greater action at the global scale to end the tobacco epidemic once and for all.

The World Heart Federation regularly produces policy and technical papers to advocate, educate, and provide recommendations on specific tobacco control issues. Our policy briefs are produced by teams of experts under the supervision of the WHF Tobacco Expert Group. WHF will be launching two new policy briefs on "Nicotine and Cardiovascular Health" and "The Impact of Tobacco on the COVID-19 Pandemic", prior to the Tenth Session of the Conference of the Parties to the WHO FCTC.
